The attention of the Commissioners of the Urban Local Bodies in the State mentioned in the list enclosed is invited to the references cited and they are informed that Government in an attempt to enhance 'Ease of Doing Business' in Telangana State, have introduced several reforms and has taken steps for effective implementation of the same and one of the reforms is "Integration of mutation process with registration process through automatic update of land and municipal records during property registration" duly sharing the web services between Registration & Stamps Department and Municipal Administration Department.

2. As per Government mandate, after online receipt of mutation applications from Registration & Stamps Department, the Municipal Commissioners shall process and issue online mutation certificates within 15 days without fail. But, as per the latest report received from EMAS Support Team, it is observed that, 880 mutation applications are still under process in 43 ULBs even after the elapsed time of 15 days and even after receiving the data with proper PTIN/ VLTN numbers, which is unsatisfactory. The following are the details of number of mutation applications pending ULB-wise:

 - (ii) Process and issue online mutation certificates within 15 days from the date of online transfer of mutation applications from Registration & Stamps Department without fail, as Ease of Doing Business is a prestigious initiative of Telangana Government which has to be implemented scrupulously.

The Regional Director-cum-Appellate Commissioners of Municipal Administration of Warangal and Hyderabad are requested to review the progress of issue of online mutation certificates on a daily basis in the ULBs of their jurisdiction and ensure that the Government initiative is implemented scrupulously within the timelines.
