In the references 1<sup>st</sup> to 2<sup>nd</sup> cited, Government have issued Budget Release Order and Administrative Sanction respectively for an amount of Rs. 43,20,49,000/-, towards 2<sup>nd</sup> instalment for 2011-12 to (06) Municipal Corporations under 13<sup>th</sup> Finance Commission in relaxation of Treasury Control and Quarterly Regulation orders by obtaining supplementary grants at appropriate time during 2014-15 to C&DMA.

2. In the said G.Os, the Government have instructed the Director of Treasuries and Accounts, Hyderabad to adjust the above amounts to the P.D. A/c of the Municipal Corporations and authorize the C&DMA, Telangana Hyderabad to draw the amounts.

3. Accordingly, in the reference 3<sup>rd</sup> cited, the Director of Treasuries and Accounts, Hyderabad have communicated to the PAO/District Treasury Officers concerned and requested to admit bills to the extent budget allotments to 06 Municipal Corporations and also requested to make necessary entries in the registers maintained for the purpose.

4. The Commissioners of Municipal Corporation, noted in the address entry are informed that the 13<sup>th</sup> Finance Commission Grants now released shall be utilised exclusively for the purpose of works executed under 13<sup>th</sup> Finance Commission only and any deviation in the matter will be viewed seriously. The Commissioners will be personally held responsible for any deviation in incurring the 13<sup>th</sup> Finance Commission grants to other works if any executed in the Municipal Corporations. If the amounts incurred for the above items of work more than the amounts sanctioned under 13<sup>th</sup> Finance Commission grants, the differential amount shall be met from the Municipal General funds.

5. Therefore while enclosing the Authorization copy of the DTA, the Commissioners of Municipal Corporation noted in the address entry are requested to utilise the entire 13<sup>th</sup> FC grant immediately on priority basis and send the UCs for the utilized amount by 17.8.2014 Component wise and voucher wise for the releases already made under the 13<sup>th</sup> Finance Commission grants in the prescribed proforma.

6. Any delay in submission of UCs will be viewed very seriously.
