MINUTES OF THE 13<sup>TH</sup> MEETING OF THE SANCITONING & MONITORING COMMITTEE OF 13<sup>TH</sup> FC GRANTS HELD ON 25.08.2014 AT 3.00 PM IN THE CHAMBERS OF THE CHAIRMAN & PRINCIPAL SECRETARY TO GOVERNMENT, MA&UD, GOVT.OF TELANGANA, HYDERABAD.

## PRESENT: Dr. S.K. Joshi /AS

The meeting of the Sanctioning and Monitoring Committee (SMC) under 13<sup>th</sup> FC Grants was held on 25.08.2014 at 3.00 PM under the Chairmanship of the Principal Secretary to Government, MA&UD, Govt., of Telangana, Hyderabad, and Chairman of SMC, on preparation of revised Annual Development Plans under 13<sup>th</sup> FC Grants for the FY 2014-2015 by the Urban Local Bodies in the State for providing better Urban Civic Services and all round development of the civic bodies duly involving the elected representatives.

- 2. At the outset of the meeting, Commissioner & Director of Municipal Administration has briefed the progress of 13<sup>th</sup> CFC Grants, its admissible components and utilization of earlier releases and development witnessed in the ULBs etc., to the Committee. The C&DMA has requested the SMC to approve the Annual Development Plans received from the ULBs for the FY 2014-15 for the amount of Rs.267.47 Crores out of the total amount of Rs.268.01 Crores released from the Central Finance Commission.
- 3. The list of Officers, who have attended the Meeting is annexed.
- 4. After discussions and review, the following decisions were taken and approved by Sanctioning and Monitoring Committee;
  - 1. Guidelines shall be issued to utilize the amount earmarked for implementation of Service Level Benchmarks in the ULBs of the State
  - 2. The SMC has authorized the C&DMA for approval of revised Action Plans if any proposals received from the ULBs in lieu of sanctioned works from the year 2011-12, 2012-13, 2013-14 and 2014-15 onwards taken up under 13<sup>th</sup> CFC Grants.
  - 3. The SMC has approved revised Annual Development Plans for the FY 2014-15 for the amount of Rs.267.47 Crores received from 67 ULBs except Andole and Jogipet.
