RULES ADAPTATION - A.P. Municipal Health (Municipalities) Subordinate Service Rules, 2012 - Adaptation to the State of Telangana - Amendments - Orders - Issued.

- 1.The Andhra Pradesh Reorganisation Act, 2014 (Central Act No.6 of 2014).
- 2.From the Commissioner and Director of Municipal Administration, Telangana State, Hyderabad Letter No.5386/2012-M1, Dated:11.06.2015.

ORDER:

Whereas, by virtue of Section 3 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No.6 of 2014), the State of Telangana comprising the territories specified therein has been formed on and from the appointed day i.e., 02.06.2014.

2. And whereas, in Section 101 of the Andhra Pradesh Reorganization Act, 2014, a provision has been made for the purpose of facilitating the application of any law (as defined in Section 2 (f) of the Act), made before the appointed day, in relation to the State of Andhra Pradesh or the State of Telangana, the appropriate Government may before expiration of two years from 02.06.2014, by order, make such adaptations and modifications of the law, whether by way of repeal or amendment, as may be necessary or expedient, and thereupon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other competent authority.

3. And whereas, Andhra Pradesh Municipal Health (Municipalities) Subordinate Service Rules, 2012, made under the Andhra Pradesh Municipalities Act, 1965 (Andhra Pradesh Act No.6 of 1965) issued in G.O.Ms.No.84, MA & UD (G1) Department dated:14.02.2012 are in force as on 01.06.2014.

4. Now, therefore, after careful examination, Government have decided to adapt the Andhra Pradesh Municipal Health (Municipalities) Subordinate Service Rules, 2012, which are in force as on 01.06.2014 with some modifications/amendments.

5. Accordingly, the following Notification shall be published in an Extraordinary Issue of the Telangana State Gazette dated:02.06.2016.

NOTIFICATION

In exercise of the powers conferred by Section 101 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No.6 of 2014), the Government of Telangana hereby makes the following order namely:

1.This order may be called the Andhra Pradesh Municipal Health (Municipalities) Subordinate Service Rules, 2012 (Telangana Adaptation) Order, 2016; and

2.In the Andhra Pradesh Municipal Health (Municipalities) Subordinate Service Rules, 2012,

- (1) Throughout the Rules, except occurring in the citation of the Act, for the words "Andhra Pradesh", the word "Telangana" shall be substituted.

(2) In rule 4, in the Table there under-

(i) against category-2 in column(2) for the existing words the following words shall be substituted:

- (1) By direct recruitment to the extent of 75% of the vacancies.
- (2) By Promotion to the extent of 25% of vacancies from the feeder category of Health Assistant.

(ii) against category 3 in column(2) for the existing words the following words shall be substituted:

- (1) By direct recruitment to the extent of 50% of the vacancies.
- (2) By promotion to the extent of 25% of the vacancies from the category of Public Health Maistry / Public Health Jawan/ Sanitary Maistry /Sanitary Jawan".
- (3) By promotion to the extent of 25% of the vacancies from the category of Public Health Worker.

A common seniority list in the categories mentioned in Sl.No.2 above shall be prepared for promotion.

(iii) under the table, the existing Note and proviso there under shall be substituted with the following; namely

"Note(1):Appointment by promotion to the posts under category 3 shall be made by the Public Health Maistry/Public Health Jawan/ Sanitary Maistry/Sanitary Jawan to the extent of 25% of the vacancies and from the category Public Health Worker to the extent of the 25% of the vacancies. However, the Public Health Worker shall not be junior to any qualified Public Health Maistry/Public Health Jawan/Sanitary Jawan in the earlier cadre. If junior, this point shall also go to Public Health Maistry / Public Health Jawan/Sanitary Maistry/Sanitary Jawan."

"Provided that when there are no qualified Public Health Maistry/Public Health Jawan/Sanitary Maistry/Sanitary Jawan in the Municipality, a Public Health Worker who has put in more than 3 years of service and possessing the qualifications prescribed, shall be promoted as Health Assistant."

(iv) under the table, after the Note(1), the following Notes shall be added; namely:

NOTE(2):Method of appointment and cycle/order for the post of Sanitary Inspectors (Category-2) shall be as follows:

1 st Vacancy	:	Direct Recruitment
2 nd Vacancy	:	Direct Recruitment.
3 rd Vacancy	:	By promotion from the post of Health Assistant.
4 th Vacancy	:	Direct Recruitment.
5 th Vacancy	:	Direct Recruitment.
6 th Vacancy	:	By promotion from the post of Health Assistant.
7 th Vacancy	:	Direct Recruitment.
8 th Vacancy	:	Direct Recruitment.

NOTE (3) : Method of appointment cycle/order for the post of Health Assistants (Category-3) shall be as follows:

1 st Vacancy	:	Direct Recruitment.
2 nd Vacancy	:	By promotion from the post of Public Health Maistry/ Public Health Jawans/Sanitary Maistries Sanitary Jawans.
3 rd Vacancy	:	Direct Recruitment.
4 th Vacancy	:	By promotion from the post of Public Health worker.
5 th Vacancy	:	Direct Recruitment.
6 th Vacancy	:	By promotion from the post of Public Health Maistry/Public Health Jawans/Sanitary Maistries /Sanitary Jawans.
7 th Vacancy	:	Direct Recruitment.
8 th Vacancy	:	By promotion from the post of Public Health worker.
9 th Vacancy	:	Direct Recruitment.
10 th Vacancy	:	By promotion from the post of Public Health Maistry/Public Health Jawans/Sanitary Maistries /Sanitary Jawans.

3. In rule 6 in the table thereunder -

(i) against Sl.No.1, in column 3, under the Heading Qualification,

(a) after item (i) the following Note shall be inserted namely -

Note: In respect of in service Sanitary Inspectors existed as on the date of issue of Rules, i.e., 14.02.2012, if no qualified persons is available, promotion may be considered with Bachelors Degree.

(b) for the item(ii) the following shall be substituted; namely,

"(ii) Sanitary Inspector Training Course /Multi Purpose Health Assistant Training Course Certificate awarded by the Chairman, Board of Examinations constituted by State Government or from Government of India / State Government recognized institution".

(ii) against Sl.No.2, in column 3, under the Heading Qualification.

(a) after item (i), the following Note shall be added; namely

Note: In respect of in service Health Assistants existed as on the date of issue of Rules, i.e. 14.02.2012, if no qualified persons is available, promotion may be considered with Bachelors Degree.

(b) for the item(ii) the following shall be substituted; namely

"(ii) Sanitary Inspector Training Course / Multi Purpose Health Assistant Training Course Certificate awarded by the Chairman, Board of Examinations constituted by State Government or from Government of India / State Government recognized institution".

(iii) against Sl.No.3, in column3, under the Heading Qualification;
for item (i) the following shall be substituted; namely

"(i) An Intermediate with Biological Science or 10+2 equivalent
standard with Biological Science as one of the subjects.

Note:In respect of in service Public Health Maistry / Public Health
Jawan / Sanitary Jawan / Sanitary Maistry and Public Health
Worker existed in the service as on the date of issue of Rule
i.e. as on 14.02.2012, if no qualified person is available,
promotion may be considered with Intermediate or an
equivalent education".


