The attention of all the Municipal Commissioners in the State are invited to the subject cited and it is hereby informed that under Section 161(1) of Telangana Municipalities Act 2019 "*the Municipality shall take steps to remove, put down and abate all nuisances affecting public peace, tranquility, public safety, public health, morals and decency within its jurisdiction on public or private premises, and may proceed at law against any person committing any such nuisances for the abatement thereof and for damages.*"

2. In this regard, it is to inform that the Hon'ble Chief Minister during the meeting held on 18.02.2020 with all Hon'ble Ministers/MLAs/Mayors/Chairpersons, District Collectors, Additional Collectors & Municipal Commissioners at Prgathi Bhavan has issued instructions to clear garbage in entire town including plots. The Hon'ble Minister for MA&UD, Ind., & IT&C during his visit to Devarkonda Municipality on 25.02.2020 during Pattana Pragathi programme has expressed his displeasure over accumulation of garbage in open plots and the inaction of the Municipal authorities to take action as per the rules.

3. In view of the above, all the Municipal Commissioners in the State are hereby instructed to take necessary action for Cleaning of Open Plots and issue notices to the violators and impose fines under Section 161 (3) of Telangana Municipalities Act 2019 by collecting clearing charges along with penalty and administrative cost.

3. Therefore, all the Municipal Commissioners in the State are hereby directed to follow the above instructions scrupulously and report compliance.


