Ref:- 1. Instructions of Honble Minister for MA&UD, Ind, IT & C during review on 10.08.2020 2. This office Circular.Roc.No.E-198360/2020/H2, Dt. 11.08.2020 addressed to all the Municipal Commissioners in the State.

The attention of all the Municipal Commissioners in the State are invited to the subject, references cited.

- 2. Further all the Municipal Commissioners were requested to submit requirement of toilets ward wise locality wise of Toilet less households / house with insanitary toilets in the format prescribed and also instructed to utilize "Property mapping-Bhuwan" app going on for identification of toilet less houses and also insanitary toilets during house to house survey.
- 3. Therefore, all the Municipal Commissioners in the state are hereby instructed to upload the applications on http://swachhts.cgg.gov.in/ through the Userids and Passwords already communicated to you and take immediate action for construction of Individual house hold toilets and conversion of insanitary toilet (LOBs) into sanitary toilets immediately and complete the same by 2nd of October 2020. Funds shall be released based on the applications uploaded on the website and payment shall be done only after construction of toilets and aadhar seeding in the website duly uploading photographs of the toilets. It is once again informed that incentive for constriction of IHHL is Rs 12,000/-out of which Rs 4,000/- is Govt. of India share and Rs 8,000/- is Government of Telangana share (Total 12,000/-). In case of conversion of insanitary toilet to Sanitary toilet Government of India share is Rs 4,000/- and Government of Telanagana Share is Rs 3,000/-per toilet.(Total Rs 7,000/-) and state matching share can be from state matching share of Pattana Pragathi grants being released.
- 4. All the guidelines issued on the above subject shall be followed scrupulously and target shall be completed by 2nd October,2020. All payments to the beneficiaries shall be made through online mode into their Bank accounts and no where cash disbursements shall be made. Any deviations will be viewed seriously.
