The attention of all the Municipal Commissioners in the State are invited to the subject, cited and it is to inform that the PattanaPragathi Programme was launched on 24<sup>th</sup> February, 2020 in all the municipalities across the state and enthusiastically responded to the mandate and are striving to improve access to sanitation by developing public toilets, community toilets, SHE toilets etc in large numbers. Innovative designs and O & M practices are being introduced. Further it is informed that Telangana is the only state in the Country to have introduced public conveniences at scale, especially for women.

2. Further to support towns in ensuring timely completion of public conveniences with quality standards and to ensure good operation and maintenance of these facilities, Director of Municipal Administration in partnership with the Administrative Staff College of India (ASCI) has developed a **PattanaPragathi Toilet Monitoring System (PP-TMS) App**. This app will help Additional Collector and Municipal Commissioners to track the progress and sustainability of facilities.
