The attention of all the Municipal Commissioners in the State are invited to the subject, reference cited and it is to inform that the Government with the support of Administrative Staff College of India (ASCI) has developed a Pattana Pragathi Toilet Monitoring System (PP-TMS) to track the progress and sustainability of the public conveniences.

2. In this regard all the Municipal Commissioners in the State were directed to fill the information on the toilet infrastructure in the web portal and in this process the following points have come to our notice, the same are detailed below:-

- Many ULBs have not made arrangements for good Operation and Maintenance (O&M) of the public conveniences constructed under the Pattana Pragathi program. These ULBs are requested to take immediate action and make arrangements for O & M. A circular was issued by CDMA office for engaging SLFs for O&M of PT/CTs.
- The data related to toilets in fuel stations is not updated by most ULBs. These ULBs are requested to gather the information on toilets in fuel stations situated in ULB limits and update the web portal.
- Three ULBs namely Narsapur, Nandikonda, and Nakrekal have not yet started the data entry and are requested to complete it at the earliest.
- All ULBs are requested to update latest data, especially related to SHE toilets and mobile toilets.

3. Therefore all the Municipal Commissioners in the State are hereby directed to take immediate action and update the information on the PP-TMS web portal by 1.11.2020 of October 2020 without fail.
