The attention of all the Municipal Commissioners in the State are invited to the subject, reference cited wherein a Memorandum of Understanding has been entered with TS Agro Industries Development Corporation Limited on 2.10.2020 in the presence of Hon'ble Minister for MA&UD, Industries & IT&C, for buy back of compost in ULBs.

2. In this regard all the Municipal Commissioners in the State are hereby directed that pursuant to the above agreement, TS AGRO shall buy back compost and market them under the brand " Telangana Siri" . Hence all Municipal Commissioners are instructed to take action on the following points immediately.

- a. Collect wet waste separately from all House holds, commercial establishments, markets etc and do windrow/vermi composting.
- b. develop composting duly following standard procedure. If any queries, the Municipal Commissioners can contact Compost Development officer, Smt. Hema Latha (9849905762) in this office for information
- c. After developing compost, sample shall be sent for laboratory for testing and report shall be preserved for record. Only the batch which are within permissible standards should only be sold to TS AGRO.
- c. SHG/SLF shall be encouraged to participate in the activity.
- d. It may be noted that TS AGRO will not buy back compost of low quality. Hence only good quality compost done thorough standard operating procedures shall only be bought by the agency.
- e. A person preferably Environmental Engineer/Sanitary Inspector may be appointment to liaison with TS AGRO for marketing the compost.

3. The Action taken in the matter shall be informed to this office without fail.
