  - (1) Appellate Authorities (other than Government and Judges) shall dispose the Appeals within 15 days and
  - (2) Wherever the Appeals have to be disposed by the Government, the same shall be disposed within 21 days
- 3. Government therefore requested to take necessary action accordingly and to upload the same in the websites and DPMS software system being developed for online approval of building permissions/ CLUs duly ensuring wide publicity of the above instructions through display in Notice Boards.
- 4. In view of the above, the orders issued by Government vide references 1<sup>st</sup> and 2<sup>nd</sup> cited on Appellate Authorities and Time Limits for disposal of appeals relating to land and constructions permits are communicated herewith to the Commissioners of all ULBs in the State for strict compliance.

In an attempt to enhance the 'Ease of Doing Business' in the State of Telangana, Government have introduced several reforms and has taken steps for the effective implementation of the same. The reforms include Development Permission Management System (DPMS) for online Building Plan Approval and Change of Land Use; simplification of existing building rules, streamlining of procedures; classification of buildings based on risk and 'establishment of a dedicated conflict resolution mechanism for land and construction permits is one among them and same is under active consideration of the Government.

In this regard they are aware, following appeal provisions are available under the HMC / Municipalities / UDA Acts.
