The attention of the Commissioners of all Urban Local Bodies in the State excluding GHMC is invited to the reference cited wherein Government directed all the Urban Local Bodies and Urban Development Authorities in the State to upload all the approved layouts including open spaces, roads etc. in the websites of Municipal Administration and Urban Development and Registration Departments and also to upload the layout permission/ LRS as and when they are given, in the said websites and to submit compliance report to Government by 19.05.2016.

2. In view of the above, while forwarding a copy of reference cited, the Commissioners of all ULBs in the State excluding GHMC are directed to upload all the approved layouts including open spaces, roads etc. in their respective websites and also in the websites of Registration Departments. Further, they are also directed to upload the layout permission/ LRS as and when they are given, in the said websites and submit compliance report to Government, CDMA and DTCP by 19.05.2016 without fail.

The Regional Director-cum-Appellate Commissioners of Municipal Administration of Warangal and Hyderabad are directed to pursue action with the respective Regional Deputy Director of Town & Country Planning and Municipal Commissioners under their jurisdiction and ensure the data of all the approved layouts including open spaces, roads etc. are uploaded by them in their respective websites of Municipal Administration and also in the websites of Registration Department and to submit compliance report by 19.05.2016 without

fail as the EoDB is the Top Priority item of Telangana Government and ensure to complete the same within the time limit.
