All the Municipal Commissioners in the State (except GHMC) are informed that, the Government while enclosing the Minutes of the Co-ordination meeting held on Telangana formation day held in the Chambers of Chief Secretary on 13.5.2015 have issued certain instructions on the activities to be taken up by the Departments concerned for the successful conduct of the State Formation Celebrations from 1st June/2015 to 7th June/2015. As per the activities prescribed for the Departments concerned the following activities shall be taken up from 2nd June/2015 to 7th June/2015:

- Unfurling of flags on 2nd June 2015 and illumination of all Government buildings from 1st to 7th June 2015.

2. Further, they are informed that, there could be every possibility to attend the celebration programmes by Hon'ble Chief Minister and other Cabinet Ministers of Government and local Members of Parliament and Members of Legislative Assembly and other dignitaries in Municipal areas. In such cases, the presence of Municipal Commissioner and other Staff members of Municipalities are very much essential to District Administration to entrust the important celebrations works which have to be taken up on priority basis and also to look after the other important things like management of sanitation and other amenities like providing the drinking water to the public participating in the celebrations in Municipal Jurisdictions. Keeping in view of the above all aspects, it is decided to instruct all the Municipal Commissioners take up the above activities in their jurisdiction and not to avail any kind of leaves during the above celebrations period and available to the District Administrators in all times for their further instructions.

3. In view of the above all aspects, all the Commissioners of Municipal Corporations (except GHMC), and Municipal Commissioners of Municipalities and Nagarapanchayats are hereby instructed to take up the activities mentioned prescribed by the Government in the above para in consultation and Co-ordination with the District Administration and not to avail any kind of leaves during the above celebrations period without prior permission of the District Collector

and concerned Regional Director cum Appellate Commissioners and ensure their availability to the concerned District Administrators and higher authorities in all the times for their instructions. Any discrepancy on the above instructions will be viewed seriously and appropriate action will be initiated.
