**Sub:-** Suits – Supreme Court of India SLP (C)No. 8519/2006 dt. 30.08.2013 (from the judgement and order dt. 02.05.2006 in SCA No. 9686/2006 of High Court of Gujarat a Ahmedabad) regarding unauthorized structures including unauthorized religious structures on public roads, pavements, sideways and other public utility places and steps taken for removal of such unauthorized structures – Action taken report called for - Regarding.

The attention of the Commissioners of all ULBs in the State is invited to the reference cited wherein Government while enclosing a copy of Note No. 283/CSP/2016, dt. 10.06.2016 of Chief Secretary to Government along with gist of judgement of Hon'ble Supreme Court in SLP (C)No. 8519/2006 dt. 30.08.2013; requested the GHMC, CDMA, HMDA and DTCP to identify the religious structures on public roads in their concerned areas and to take immediate action to implement the Hon'ble Supreme Court orders and to furnish the action taken report to Government immediately.

2. The Hon'ble Supreme Court of India passed the following orders dt. 30.08.2013 in SLP (C) No. 8519/2006 (from the judgement and order dt. 02.05.2006 in SCA No. 9686/2006 of High Court of Gujarat a Ahmedabad) regarding unauthorized structures including unauthorized religious structures on public roads, pavements, sideways and other public utility places and steps taken for removal of such unauthorized structures:

*".....We accordingly direct the Chief Secretaries of the States and Administrators of the Union Territories to state on affidavit the position with regard to unauthorized structures including unauthorized religious structures on public roads, pavements, sideways and other public utility places and steps taken for removal of such unauthorized structures. Each State except the states and union territory which have been exempted by order dated July 27,2010 shall file affidavit within six weeks from today. Advocates-on-record for these States and Union Territories shall supply copy of the affidavit to Ms. Binu Tamta, Counsel for the Union of India to enable her to place on record the position obtaining in all States in a consolidated form."*



3. In this regard, it is inform that, earlier in the composite state of A.P., this office vide Circular Roc.No. 21237/2013/N3, dt. 18.10.2013 have already directed the Commissioners of all ULBs in the State to furnish information on authorized structures including unauthorized religious structures on public roads, pavements, sideways and other public utility places and steps taken for removal of such structures. But, so far, no reply has been received from them.

4. In view of the above, while forwarding a copy of reference cited, the Commissioners of all ULBs in the State are directed to furnish the action taken report in pursuance of the orders of Hon'ble Supreme Court dt. 30.08.2013 in SLP (C) No. 8519/2006 in the prescribed proforma enclosed to the RDMA concerned who in turn shall compile and furnish a consolidated report to this office by 22.07.2016, so as to enable the Chief Secretary to Government to file an affidavit in the Hon'ble Supreme Court on behalf of Telangana State.

5. This shall be treated as MOST URGENT.
