I invite your attention to the references cited.

2. In the reference 1<sup>st</sup> and 2<sup>nd</sup> cited, the Secretary, State Election Commission have issued detailed instructions for selection of polling stations in respect of Municipal Corporations and Municipalities respectively. Further in the reference 3<sup>rd</sup> cited, the Secretary, SEC have issued a time schedule for publication of ward wise list of polling stations, which commences from 31.7.2015 and ends with 18.8.2015.

3. In this context, I wish to inform that as per the provisions of GHMC Act, 1955 the approval for final publication of polling stations has to be given by the Commissioner of the Municipal Corporation concerned and the final list of polling stations of the wards has to be published by the Returning Officers concerned appointed by the SEC. In respect of Municipalities/Nagarpanchayats the approval for final publication has to be given by the District Election Authority & Collector and has to be published by the Election Officer concerned.

4. I, therefore, request you to take immediate action for Selection, Preparation and Publication of ward wise polling stations as per the instructions issued by the SEC vide reference 1<sup>st</sup> and 2<sup>nd</sup> cited duly adhering to the time schedule given by the SEC vide reference 3<sup>rd</sup> cited.

5. I also request you to furnish a copy of the final list of polling stations of your ULB to this office and also to the State Election Commission for record.

6. Any deviation to the instructions issued by the SEC will be viewed seriously.




