**Sub:-** Municipal Administration Department – Strike of Municipal workers in the ULBs of the State from 06.07.2015 - Ensuring proper maintenance of essential services viz. Sanitation, Water Supply, Street Lighting etc. during the ensuing public holidays occurring on 18.07.2015 (Ramzan) & 19.07.2015 - Certain instructions – Issued.

The attention of all the Commissioners of Urban Local Bodies in the State (except GHMC) is invited to the reference 2<sup>nd</sup> cited wherein instructions were issued in view of strike of Municipal workers from 06.07.2015 to prepare and follow the Contingent Plans for tackling the strike situation in respect of essential services in the ULBs viz. Sanitation, Water Supply etc. and to ensure normalcy of public life.

2. Further, the Regional Director-cum-Appellate Commissioners of Municipal Administration in the State were also requested to oversee the contingent plans that would be implemented in the ULBs of their jurisdiction and to give necessary directions and proper guidance to the Municipal Commissioners.

3. In this context, the Municipal Commissioners are aware of the fact that two public holidays are occurring on 18.07.2015 & 19.07.2015 for Ramzan Festival and Sunday respectively during which the essential services in the ULBs viz. Sanitation, Water Supply, Street Lighting etc. needs to be concentrated upon more particularly in vulnerable areas of the cities & towns to keep them clean and sanitary and all measures shall be taken for effective maintenance of the same duly making alternative arrangements, so as to avoid various kinds of water borne and vector borne diseases due to contamination of drinking water and breeding of mosquitoes, flies etc. and ensure the public celebrate EID in a joyous atmosphere.

4. The contingency plans already communicated by this office for proper maintenance of Sanitation & Water Supply in the ULBs shall be strictly adhered and followed scrupulously, duly taking police protection wherever necessary.

5. Further, they are also directed to submit a daily report on the no. of employees participated in the strike, percentage of essential services effected & restored to their respective RDMA who in turn shall compile the information and submit a consolidated report to this office by 4.00 P.M. every day without fail and also directed not to avail public holidays on the respective dates.
