The attention of all the RDMA's and Commissioners of all the ULBs in Telangana State, is invited to the references cited. As per the instructions issued by the Government in the reference 1st cited, the Commissioners of all the ULBs were requested in the reference 2nd cited, to submit revised Annual Development Plans for the financial year 2014-2015 for providing better urban civic infrastructure and all round development of the Civic Bodies under 13th Finance Commission Grants, duly involving the elected representatives.

2. Further, in the reference 3rd cited, Government have issued certain guidelines for preparation of Micro Level Plans for Mana Wardu- Mana Pattanam- Mana Pranalika in the process of implementation of Nava Telangana-Navya Pranalika and the same has been communicated to all the ULBs for taking further action in the matter.

Accordingly, the Municipal Commissioners have prepared Micro level Plans on Mana Wardu- Mana Pattanam – Mana Pranalika duly involving all the stakeholders of the society i.e., SHGs, SLF, TLF, NGOs, RWAs, Senior Citizens, intellectuals, elected representatives and all political parties in that particular ward and also discussed the existing infrastructure and prepared the proposals for future requirements of that particular ward of their ULB. The Commissioners have consolidated ^{proposal at} all ward level Mana Ward- Mana Pattanam- Mana Pranalika duly discussing the same in the Council

meetings of their respective Municipalities and furnished the same to the District Collectors for onward submission to Government.

4. In view of the above, all the Municipal Commissioners in the State are instructed to take up the works as prioritized under Mana Ward – Mana Pattanam- Mana Pranalika under various schemes available i.e., 13th FC, BRGF, MP/ MLA LADs, General funds and other available funds available with the Municipality duly following the procedure and guidelines issued for various schemes.

5. The periodical action taken report on fortnight basis has to be submitted to the District Collector, Regional Director, C&DMA and Government without fail.
