The attention of Commissioners of all the ULBs in the State, is invited to the references cited, wherein several instructions were issued to update Data Entry, complete Bank Reconciliation Statement (BRS) in DEABAS Live and rectify the negative entries for the FY 2015-16. As the measure to strengthen the Accounts in DEABAS and to perform the transactions day to day the Accounts personnel have to be more responsible to keep the accounts online. Further, as per the norms of 14<sup>th</sup> Finance Commission, the Annual Accounts have to be got Audited by the Statutory Auditors and also to take measures to improve the Revenue of the ULB (Taxes, Non-Taxes & Other Revenue Income) year to year, so as to enable the ULB to draw the eligible Performance Grant.

In view of the above all the Municipal Commissioners, are instructed to get the data entry, BRS completed and finalise the Annual Accounts for the FY 2015-16. They are further instructed to send the concerned staff along with Accounts related records (i.e., Cash Book, Bank Statements & related registers) for scrutiny by this office as per the schedule enclosed for finalization of Accounts.

All the ULBs shall submit account for 2015-16 in DEABAS to the State Audit Department, by 30<sup>th</sup> April – 2016, without fail.
