ORDER:

In the reference 2nd read above, orders were issued permitting the District Collectors of Khammam, Bhadradi Kothagudem, Jayashankar Bhupalpally, Komarambhim-Asifabad, Adilabad, Mancherial, Peddapally and Jagtial to receive applications for regularization of encroachments consisting of residential and commercial units, in the lands of Singareni Collieries Company Limited (SCCL), which were handed over to the respective District Collectors, for a period of (6) months, from the date of issue of the said orders, duly following the procedure adopted in G.O.Ms.No.59, Revenue (Assn.I) Dept., dt:30.12.2014, wherein the cut of date for possession / encroachment was 02.06.2014.

2. In the reference 3rd read above, the Chief Commissioner of Land Administration, T.S., Hyderabad, requested the Government to issue orders in continuation of orders issued in G.O.Ms.No.76 Revenue (Assn.I) Department, dated 11.07.2019, for extension of time limit for a period of (3) months to receive the applications for regularization of encroachments.

3. Government, after careful examination of the matter, hereby extend the time limit for (3) three months from 1.4.2023 till 30.6.2023 to receive applications for regularization of encroachments in Singareni Collieries Company Limited (SCCL) lands, which were handed over to the Government in Khammam, Bhadradi Kothagudem, Jayashankar Bhupalapally, Komarambheem-Asifabad, Adilabad, Mancherial, Peddapally, Jagtial Districts, in terms of G.O.Ms.No.76, Revenue (Assn.I) Department, dated 11.07.2019. The cutoff date for possession/ encroachment is hereby extended from 02.06.2014 to 02.06.2020.

4. The District Collectors of Khammam, Bhadradi Kothagudem, Jayashankar Bhupalapally, Komarambheem-Asifabad, Adilabad, Mancherial, Peddapally, Jagtial and the Chief Commissioner of Land Administration, T.S., Hyderabad shall take necessary further action, in the matter, accordingly.
