Sub:- Mpl Admn Dept-Handling Municipal Solid Waste in all the ULBs as per TS Mpl Act, 2019-Certain instructions issued-Reg.

Ref:- 1. C.No.556/M(IT, MA & UD, I&C)/2021, Dt.28.08.2021 of the Hon'ble Minister for MA & UD, IT and I&C.

- 2. This Office Lr.Roc.No.191968/2020-H2, Dt.07.07.2020 addressed to all the Municipal Commissioners.
- 3. This office circular Roc No. 28079/2020/H2 dt 3.2.2021

I invite your attention to the references cited.

- 2. In the reference 1st cited, the Hon'ble Minister for MA & UD, IT and I&C have issued directions to focus on handling of Municipal Solid Waste in all the ULBs as per the TM Act, 2019 by preparing a comprehensive and sustainable plan in ULBs.
- 3. Further, he has further instructed that segregation of waste is a crucial task in handling of Solid Waste in Urban Areas. As per the provision of the TS Municipal Act, 2019, segregated waste shall be collected from residential and commercial establishments in a separate strategy based on the City Sanitation Plan. As such he has instructed to evaluate performance of ULBs on each item wise and take necessary action to implement the provisions of TS Municipal Act strictly in handling Municipal Solid Waste in all ULBs.
- 4. In this connection, I wish to inform that earlier in this office reference 2nd cited, while enclosing a copy of Model RFP instructions were issued to all the Municipal Commissioners for collection of waste from Bulk waste Generators and Commercial establishments separately.
- 5. Further, I wish to inform that the Telangana Municipalities Act, 2019 has mainly focused on sanitation and also mandates the door to door collection, including source segregation and all waste collected shall be scientifically treated and disposed. It also fixed responsibility on the Citizens and elected representatives in collection of garbage and in situ development of compost. Detailed guidelines on home composting was also issued vide reference 3rd cited.
- 6. Keeping in view of the above and in order to achieve goals enacted in the Telangana Municipalities Act, 2019, it has been decided to streamline and effectively implement provision of Act and SWM Rules, 2016 in sustainable manner with the following output:-
 - Source segregation of wet (biodegradable), dry (recyclable) and domestic hazardous waste with Green, Blue and Red colored bins with lids in all units in Commercial areas and BW units.
 - Institutionalized 100% recycling of dry waste and selling to the suitable agencies

- Declaration of all commercial areas strictly implementing instructions vide ref.2 above and other areas as 'Litter Free Areas' and 100% implementation round clock and 365 days on sustainable manner.
- · Reduce the pressure on the processing units and also dump yards
- Streamline the maintenance of fleet of vehicle in sanitation & swm fitted with GPS and thereby improve efficiency.
- 7. In view of above, I request all the ACs, LB are requested to keenly monitor with the Municipal Commissioners concerned regarding collection of segregated waste from residential and commercial establishment separately and ensure that all the above activities are performed effectively and the Municipal Solid Waste is handled effectively in all the ULBs as per the TM Act, 2019.
- 8. The action taken on the above shall be intimated for appraising the same to the Hon'ble Minister.
