Further in the ref. 2nd cited, wherein the Director, DAY-NULM & SBM, Gol, New Delhi has informed that,the Hon'ble Union Minister, MoHUA has launched a five week long Clean Toilets Campaign from 19thNovember 2023 (World Toilet Day) to 25th December 2023 (Good Governance Day) and requested all ULBs to participate in the campaign.
- 4. Accordingly, vide ref. 3rd cited, this office were instructed to all the ULBs to participate in the CTC Campaign during the period 19/11/2023 to 25/12/2023.
- 5. In the ref. 4th citied, wherein the Joint secretary & MD SBM U has informed that ULBs need to expedite the construction of newly sanctioned toilet blocks as Aspirational Public Toilets. Dear Madam/Ser,

City Sanitation Action Plan (CSAP) for most of the states are approved under SBM-U 2.0 and implementation of various components are underway including those for newly sanctioned toilet blocks for Community Toilets/Public Toilets/Aspirational Public Toilets (CT/PT/APT). Requests have been received from states to allow use of SBM funds for upgradation/retrofitting/reconstruction of some of the old toilet blocks, located at prime locations, with high footfall in cities specially due to constraint of new piece of land in the area.

- 2. Under SBM-U 2.0 operational guidelines, the unit cost for construction of new normal CT/PTs is set at ₹1.5 lakhs per seat, for Aspirational CT/PT at ₹2.5 lakhs and that for Urinals at Rs. 0.32 lakhs per seat. Accordingly, it has been decided to adopt the following provisions for expeditious improvement of CT/PTs/Urinals:
 - i) Construction of CT/PTs/Urinals at new sites with SBM-U 2.0 funding as above. State/ULB can converge additional resources as per requirement.
 - ii) Complete reconstruction of dilapidated/structurally weak toilet blocks by demolishing old structure (built pre-2014) at the same site.
 - iii) Dysfunctional toilets requiring upgradation, funds upto 50% of new construction cost can be used for the purpose.
 - iv) Construction of Aspirational CT/PTs at the new sites with SBM-U 2.0 fund as above. Aspirational toilets to be facilitated preferably at Tourist/Pilgrimage/high footfall areas/ Million plus cities/Capital cities/ Similar areas.
 - v) All the CT/PTs to be women & child-friendly. Special care to be taken while designing the toilet towards differently-abled, senior citizen etc.
 - vi) Above activates to be undertaken within allocated funds for the State under mission for Sanitation. However, additional funds, if required, can be availed only for Heritage cities/High footfall areas.

At the end of drive, CT/PTs must look visibly better/ more functional and adhere to FACES parameters.
