2. This Office Cir.Roc.No.142939/2019-H2, Dt.13.06.2020 addressed to all the MCs.

The attention of all the Municipal Commissioners is invited to the reference 1<sup>st</sup> cited, wherein the Government have instructed to install GPS in all Swachh autos in next 06 weeks wherever GPS is not installed and the payments / bank rentals may be held back for all swachh autos where GPS is not installed/functional by 30.01.2022.

2. In this regard, it is to inform that in the reference 2<sup>nd</sup> cited, instructions were already issued to all the MCs to assess the requirement of the sanitation vehicles keeping in view of the road worthiness of the present available vehicles, identify the gaps and procure the vehicles in all the ULBs.

3. Accordingly, 2214 new vehicles were procured by the ULBs during the Pattana Pragathi Programme. In order to have proper collection of Garabage and to prevent the misuse of vehicles / underutilized it is necessary to install GPS tracking in every vehicle especially Swachh autos.

4. Therefore, all the MCs are hereby instructed to install GPS in all Swachh autos in next 06 weeks wherever GPS is not installed before 30.01.2022 and report compliance to this office.

The Hon'ble Minister, MA&UD has flagged off 1350 Swach Auto vehicles recently thereby the total no. of Swach Autos being around 4500 in GHMC.

The time has come that each of these Swach Autos must have the GPS so that proper mapping can be done on their routes and to ensure that door to door collection coverage is saturated in entire GHMC. This will also help to prevent the misuse of vehicles only for the purpose of collecting bulk garbage and that they are not underutilized.

Details may accordingly be worked out for the GPS installed in Swach Autos in next 6 weeks and action taken may kindly be intimated.

The payments / bank rentals may be held back for all Swach Autos where GPS is not installed / functional by 30<sup>th</sup> January, 2022.
