Therefore, all the MCs are hereby directed to submit the Medical Reimbursement Proposal to this office through the concerned appointing authorities i.e., Collector & District Magistrate concerned/ RDMAs for reverification and scrutiny of all documents i.e., Representation Letter, Appendix-II, Emergency Certificate, Essentiality Certificate, Discharge Summary, Hospital Recognition, Medical Bills, Pension Payment certificate, Non-Drawal Certificate, Bank Details, Certification of regular Employee of the Municipality along with the Attested ID Card inclusive of employee/Pensioner ID No., etc., in original along with 2 sets of Xerox copies, (In case if employee is expired, the following documents shall be enclosed such as Death Certificate, Legal Heir Certificate, No-Objection from other family members, etc.,.) so as to forward the same to the Director of Medical Education, TS., Hyderabad.
- 4. All the Original Medical Bills received from various MCs pertaining to sanitation personnel i.e., PH Worker/Health Assistant are returned herewith the above direction and requested to take necessary action.
