Sub: Preparation of 14th FC Revised Annual Development Plans for the differed works - for the year 2015-16 by the ULBs for improvement of Urban Services and Implementation of DEABAS in all the ULBs - Amount released and sanctioned under 14th Finance Commission for DEABAS may be returned - Necessary instructions issued - Reg.

The attention of all the Municipal Commissioners noted in the address entry is invited to the reference cited, wherein it is informed to submit the revised Annual Development Plans for the differed works for the year 2015-16 under 14th FC as per the following admissible components only:

- A. Basic Services (Not exceeding 70%)
 - i. Drinking water supply
 - ii. Street Lighting (Meters, Capacitors and Third Wire only)
 - iii. Road works (CC roads only)
 - iv. Drains
- B. Other Infrastructure
 - i. SWM Activities
 - ii. Development of Burial Grounds
 - iii. Development of Vegetable markets
 - iv. Development of Non-Veg. Markets
 - v. Construction of compound wall to open spaces
 - vi. Development/Construction of Slaughter houses
 - vii. Development of Junctions, Medians and parks
 - viii. Viability gap funding for any PPP mode
 - ix. IT related Services

2. However, it is observed that most of the Municipal Commissioners are submitting the revised ADPs without mentioning the works clearly and also not as per the admissible components. This is causing un-due delay in sanctioning the works, calling of tenders and execution of works.

3. Therefore, all the Municipal Commissioners noted in the address entry are once instructed to prepare the revised ADPs in place of differed works for the year 2015-16 under 14th FC as per the admissible components along with technical estimates, line


diagrams and Municipal Council resolution and submit the proposals to this office in full shape strictly as per the guidelines without giving scope for unnecessary correspondence.

4. Further, you are also instructed once again to return the amount released for implementation of DEABAS to this office through Demand Draft in favor of "Commissioner & Director of Municipal Administration, Govt. of Telangana, Hyd" or online transfer (SBH, Shantinagar branch, A/c.No:62448303244, IFSC Code:SBHY0020070 & MICR Code:500004057) immediately.
