The attention of all the Commissioners of the Corporations and Municipalities in the address entry is invited to the references cited, wherein, the Hon'ble Chief Minister of Telangana has envisioned to achieve greater energy efficiency in urban local bodies to meet the growing demand for energy, and has directed the authorities to implement the Energy Conservation and Efficiency measures in ULBs of the State, particularly in street lighting, by replacing existing Street Lights with Energy Efficiency LED based Lighting System.

2. In this connection, as desired by the Government, the department has held series of meetings with M/s Energy Efficiency Services Ltd (A Joint Venture of PSUs of Ministry of Power – Govt. of India), and pilot projects have been planned in selected stretches of following 12 ULBs and which would be further scaled up to all ULBs across the State.

- 1) Karimnagar Corpn,
- 2) Nizamabad Corpn
- 3) Gajwel Nagara Panchayat
- 4) Siddipet Municipality
- 5) Siricilla Municipality
- 6) Ramagundem Corpn
- 7) Khammam Corpn
- 8) Mahboobnagar Municipality
- 9) Manchiryal Municipality
- 10) Nalgonda Municipality
- 11) Tandur Municipality
- 12) Warangal Corporation.

3. The above ULBs have furnished the existing street lighting data of selected stretches for replacement of conventional street lights with LEDs, so as to achieve energy conservation, efficiency and cost savings on energy bills.

4. In view of the above, a meeting is proposed on 09.09.2014 at 3.00 PM in the Mini Conference Hall, O/o C&DMA Hyderabad with piloting Municipalities and M/s EESL to discuss about the pilot project, and its modalities and roles and responsibilities, and to chalk out an action plan.

In this connection, all the Municipal Commissioners, Mayors/Chairpersons and Municipal Engineers (looking after street lights) are requested to attend the above meeting on 09.09.2014 at 3.00 PM in the Mini Conference Hall, O/o C&DMA Hyderabad along with electricity bills of last one year for the selected stretches of the street lights and copies of the data furnished to this office without fail. M/s EESL is also requested to attend the above meeting and make a presentation on pilot project and its outcomes etc.
