ORDER:

In the reference read above, the State Election Commissioner has issued notification to conduct elections to the Office of the Mayor and Deputy Mayor in (03) Municipal Corporations. For this purpose, under rule 3 and 4 of A.P. Municipal Corporations (Conduct of elections to Mayor/ Dy. Mayor) Rules, 2005 issued in G.O.Ms No.762 M.A, Dt.19.8.2005 subject to general superintendence, direction and control of the State Election Commission, the Election Authority and Commissioner and Director of Municipal Administration shall be responsible for conduct of elections of Mayor and Deputy Mayor. Further, a special meeting of the elected members of the corporation shall be held in the office of the Municipal Corporation by the Dist. Collector or Joint Collector authorized by the Election Authority in Form-I for election of the Mayor and Deputy Mayor.

2. In view of the circumstances stated and in exercise of the powers conferred under Section 14 of AP Municipal Corporation Act, 1994 read with rule 3 and 4 of said rules, the Election Authority and Commissioner and Director of

Municipal Administration hereby authorized Sri. Sarfraz Ahmed, I.A.S Karimnagar District to convene Special meeting of the members of Municipal Corporation, Ramagundam for the election of Mayor and Deputy Mayor in the manner laid down in the rules

Notice to be given in Form - II by the concerned District Collector/Joint Collector authorized by the Election authority calling for a special meeting for conduct of election to the Mayor/Deputy Mayor, Ramagundam Municipal Corporation. (This notice should be given to all the elected members and Ex-Officio members)	On or before 29.06.2014
Date and time of the meeting for the election of Mayor/ Deputy Mayor.	At. 11.00 A.M on 03.07.2014
