The attention of all the Municipal Commissioners noted in the address entry are invited to reference cited and they are informed that, the Hon'ble Minister for MA&UD, IT and I&C Department, Govt. of Telangana has conducted review meeting on Incessant rains & floods on 28/10/2020.

During the review meeting it was instructed to obtain the information on Reasons & Possible Solutions for occurrence of inundation due to heavy rains in the surrounding ULBs and also instructed to take necessary action for restoration and also to propose a permanent solution to avoid such inundation in the future. Therefore, keeping in view of the above scenario the Municipal Commissioners noted in the address entry are hereby instructed to demolish all the houses constructed on Nala's, Sikkams, FTL and which are causing obstruction to natural flow of rain water as per the Rules in force and report compliance to this office to prevent such incidents happening in the future.
