The Government vide reference 9th cited have accorded permission to continue the services of the (10) Environmental Engineers on outsourcing/contract basis working in the ULBs of Telangana State beyond 2nd June, 2014, subject to conditions stipulated in the G.O.Ms.No.13, dated 01.07.2014, and also subject to condition that the Department concerned shall ensure fulfilment of the following conditions in respect of contractual services:

1. The contract with the individual employees or with the Manpower Agencies shall not be treated as continuing from the past but a new contractual arrangement for a limited duration.
 2. The Departments shall not issue a generic order of contract and shall refer to the arrangement as contracting services for specific duration with specific terms of reference.
 3. The Departments shall define specific Terms-of-Reference (TOR), supervision systems, performance management system, terms and conditions of contract and monitor fulfilment of these conditions.
2. In view of the above, the services of following Environmental Engineers 9 Nos (EE Suryapet is not working) working on outsourced/contract basis on 2nd June, 2014,

with prior approval of the Finance Department, who are covered by the orders in the G.O.Ms.No.84, Finance (SMPC.II) Dept., dt:17.04.2014, G.O.Ms.No.248, G.A. (SR) Dept., dt:01.06.2014 and G.O.Ms.No.250, G.A. (SR) Dept., dt:01.06.2014 and are assigned to the State of Telangana in terms thereof, are extended until further orders or till the actual need ceases, whichever is earlier, subject to the terms and conditions specified in the G.O.2nd read above, and also subject to the terms and conditions specified in the G.O.1st read above through RCUES, Hyderabad by entering a fresh agreement.

The Municipal Commissioners concerned are instructed to enter into a fresh agreement with RCUES, Hyderabad by meeting the expenditure from out of Municipal General Fund of the ULB for the payment of the remuneration of the EEs with the consent of the Council/Standing Committee. The MCs are also requested to clear all the dues (remuneration along with ESI and PF) if any by covering in this agreement. The remuneration of EEs working in the Regional Office/C&DMA may be met from the interest amount available under 12th Finance Commission grants or any funds available with them. The Municipal Commissioners shall pay the salaries of the respective EEs if they are working from 02.06.2014 through RCUES by furnishing attendance certificates.

4. The Director, RCUES, Hyderabad is requested to enter into a fresh agreement with the above said ULBs/offices for the period of one year from 02.06.2014 to 31.05.2015 with terms and conditions as was done earlier. The RCUES is also requested to furnish monthly performance reports of the EEs to this office regularly.


