It is to inform that, as per the instructions of the Government, this office has convened series of meetings with M/s EESL on Energy Conservation and Efficient measures to be taken up in the State particularly in street lighting. Government has decided to take up the pilot study in the selected stretches of following 12 ULBs, and M/s EESL has furnished a proposal for the same (replacement of existing conventional street lights with energy efficient street lights (LEDs)).

- 1) Karimnagar Corpn,
- 2) Nizamabad Corpn
- 3) Gajwel Nagara Panchayat
- 4) Siddipet Municipality
- 5) Siricilla Municipality
- 6) Ramagundem Corpn
- 7) Khammam Corpn
- 8) Mahboobnagar Municipality

- 9) Manchiryal Municipality
- 10) Nalgonda Municipality
- 11) Tandur Municipality, and
- 12) Warangal Corporation.

2. In the reference 10th cited, Government have approved the EESL proposal and permitted the C&DMA to take up the street lighting pilot study in selected stretches of 12 ULBs of the State with M/s EESL, New Delhi as per the terms and conditions mentioned therein.

3. Further in this connection, a meeting was convened on 11.09.2014 at C&DMA office with M/s EESL and Mayors, Chairpersons, Municipal Commissioners and Engineers of 12 ULBs, in which detailed deliberations were taken place on street lighting pilot study. All the ULBs have expressed their willingness to take up the pilot study and furnished their Council Resolutions (except Khammam Corporation).

4. As a next step, M/s EESL is requested to initiate primary field level survey in the above ULBs about the existing infrastructure, i.e., No. of poles, lights and its wattages, fixtures, conditions of meters, cables and panel boards etc., and validate the baseline data provided by the ULBs for the selected stretches and submit the observations and recommendations for the rectification of deficiencies if any to this office before 20.10.2014, so as to take further necessary action in the matter prior to kick start of the pilot project.
