Sub: MA&UD - Conduct of 4th ordinary elections to urban local bodies - Preparation & Publication of ward-wise electoral rolls for conduct of casual elections to Ward.No.29 of Bodhan and Ward.No.15th of Ibrahimpatnam- Providing password-free electoral database with images to the Bodhan Municipality and Ibrahimpatnam Nagarpanchayat-Furnishing of undertaking -Regarding.

I invite kind attention of Government to the references cited. I submit that in the reference 1st cited, the Commissioner, State Election Commission have notified 20.06.2016 as the date of publication of photo electoral rolls of Ward.No.29 of the Bodhan Municipality of Nizamabad District and Ward.No.15 of Ibrahimpatnam Nagarpanchayat of Ranga Reddy District for the purpose of conduct of ordinary elections to these ULBs in the State.

2. In this regard, I wish to inform that the State Election Commission has authorized the Municipal Commissioners of the concerned ULBs for preparation and publication of the ward wise photo electoral rolls of their respective ULBs with reference to 01.01.2016 as the qualifying date duly adopting the latest Assembly photo Electoral rolls in to-to published on 31.05.2016 pertaining to the Municipal areas concerned.

3. Further, the State Election Commission in the reference 2nd cited, has requested the Government to issue instructions to the District Election Officers and Electoral Registration Officers of Nizamabad and Ranga Reddy having jurisdiction over the Urban Local Bodies in the State to provide soft and hard copies of Photo Electoral Rolls with reference to 01.01.2015 as a qualifying date along with supplements prepared under continuous up-dation till date to the Municipal Commissioners of Bodhan and Ibrahimpatnam Urban Local Bodies as per the yardstick given below:

- a. One signed hard copy (signed by the concerned ERO) of Assembly photo Electoral Rolls.
- b. One CD containing the Assembly Electoral Rolls in PDF
- c. Password free Electoral data base with photograph in digital format, wherever it is sought by the Municipal Commissioner concerned.

4. Further, the SEC has informed that the C&DMA and Election Authority will furnish an undertaking on behalf of the Municipal Commissioners in the state as stipulated at Para 7 and 8 of the terms and conditions for sharing Electoral data base issued by the ECI in its reference No.23/SEC/2008, ERS Dt.10.12.2008.


5. In view of the above, I furnish herewith the following undertaking as stipulated by the ECI:

"The ULBs under Municipal Administration and Urban Development Department, will undertake that the roll database, whether within or without photographs in digital format, is shared and will ensure that the database of the Commission is not passed on to any other agency/organization. Full security of the database would be ensured and its safe keep and bonafide use shall be the responsibility of the Department."

6. I, therefore, request the Government, to issue suitable instructions to the District Collectors and Electoral Registration Officers of Nizamabad and Ranga Reddy Districts, so as to enable the concerned Municipal Commissioners of Bodhan and Ibrahimpatnam to get the data relating to their Urban Local Bodies for preparation and publication of photo electoral roll.
