ORDER:

- The A.P. Municipal and Panchayat Workers Federation, Guntur have requested same the G.O. second read above, for entrusting the Sanitation work in Municipalities / Municipal Corporations to the Societies by PH 1.
- Government have examined the demand of the A.P. Municipal and workers-children / Badili workers. Panchayat Workers Federation for entrustment of the sanitation work to the Societies and DWCRA groups formed by the workers union by relaxing the 2. conditions of participating in tenders on the amount that they are expenditure and well experience in the sanitation work.
- Government, after careful consideration of the matter hereby to entrust a portion of sanitation work to the societies formed by the sanitary workers unions without participating in the tenders with view to improve the 3. efficiency in sanitation with the other modalities indicted in the G.O. 2nd
 - The Commissioner and Director of Municipal Administration and all the Commissioners of Municipalities and Municipal Corporations in the State read above. are requested to take necessary action accordingly.

In the reference cited, the Director of Municipal Administration, Hyderabad has submitted a proposal taking Ponnur Municipality as example and requested the Government to issue general instructions to all Municipalities/ Corporations to involve DWACUA groups for sanitation works its under SJSRY Scheme.

- 2. The Government have examined the proposal and decided to entrust sanitation and other works to DWCUA groups in all Municipalities subject to following conditions:-
 - For a period of 3 years or liquidation of the loan sanctioned, whichever is later.
 - Even after the liquidation of the loan, these DWACUA assisted units shall be given a priority in allotment of upto 50% of the privatised sanitation/total sanitation work.
 - 3. DWACUA groups can be allotted sanitation work in all the Urban Local Bodies upto 50% of the privatized sanitation/total sanitation work.
 - 4. Urban Local Bodies may make payments to Banks directly the installments due from the DWACUA units till the loan is liquidated, by making a deduction at source while making payments to the DWACUA groups for the work they have performed.
 - The DWACUA Groups shall provide the persons including labour all necessary safety equipment and first aid equipment.
 - No workmen/employees engaged by the DWACUA groups shall have any right or claim of seeking any employment in the municipality by virtue of any service rendered by them.
 - That the DWACUA groups will not engage child labour and also agree for permitting the labour a weekly off.
 - 8. DWCUA groups shall be paid the amounts due to them for the work carried out by them by way of cheques only.
 - The Urban Local Bodies in case of increase in administered prices like diesel, minimum wages etc., may make an upward/downward revision of the contract amount during the currency of the contract period, once every year.

- 10. Payments to the Banks/DWACUA units shall be made every month promptly.
- 11. In case of privatisation of disposal and management of Solid Waste as per legal and scientific norms, the private operator shall also consider using the DWACUA groups on priority and follow the same conditions. These conditions shall form part of the future agreements, if any.
- 12. The Municipality/Private operator shall ensure that a daily record of the registration number of the tractor-trailer bringing Solid Waste to a dumpsite with the number of trips performed by each vehicle is maintained where weighbridges are not installed. These records shall be analysed every month by the Municipal Commissioner and used to assess the percentage of collection and disposal against the estimated output of Solid Waste, to report in Performance Indicator statements.
- 13. Penalties must be imposed if there is a reduction in loads reaching the dumpsite, as done by MCH.
- 14. No payment for 'trips' of waste of dumpsites shall be made without accompanying records (copies) of loads actually received at the dumpsite, vehicle wise.
- 3. The Director of Municipal Administration, Hyderabad is therefore requested to issue instructions to all Municipalities/Corporations on the above lines under intimation to Government immediately.

Sub:- Reservation of shops to SCs & STs - Second Report of Committee on Welfare of SCs (2000-2002) - Certain instructions - Issued - Reg.

Ref:- Government Memo.No.15369/K1/2003, dt.1.9.2003.

The attention of the Commissioners of Urban Local Bodies is invited to the reference cited, wherein Government have communicated the minutes of the meeting of Committee on Welfare of SCs held on 27.8.2003 and have requested to take immediate action on the observations made by the Committee.

- 2. As seen from the minutes of the meeting the following observations were made by the Committee;
 - "That for all shopping complexes constructed with Government funds that are on good-will auction basis, the rule of reservation must be applied strictly: SCs and other weaker sections should not be allotted shops in perpheral areas, but within prime locations inside the complexes."
 - "In shopping allotments, allotments made already if there is existing variance with the rule of reservation these allotments must be cancelled with due notice and re-auctioned only for SCs, STs etc."

3. In this regard, it is to inform that under Regulation of Receipts & Expenditure Rules, 1968 issued in G.O.Ms.No.686 M.A., Dated: 30.07.1968, proviso (6) of Rule 12(1)(h) reads as follows;

"Provided also that in respect of shops and stalks constructed by the Municipalities, 15% of such shops and stalks shall be reserved for allotment of lease to the members of Scheduled Castes, without the normal channel of public auction, at 50% of the rent of adjacent shops or stalks leased out in public auction or Rs. 2.50 per square foot whichever is less and the production

of solvency certificate and six months advance rentals need not be insisted upon from such members of the Scheduled Castes."

- 4. Further, proviso (10) of Rule 12(1)(h) of said rules, reads as follows;

 "Provided also that in respect of shops and stalls constructed by the Municipalities, 6% of such shops and stalls shall be reserved for allotment of lease to the members of Scheduled Tribes, without the normal channel of public auction, at 50% of the rent of adjacent shops or stalls leased out in public auction or Rs.2.50 per square foot whichever is less and the production of solvency certificate and six months advance rentals need not be insisted upon from such members of the Scheduled Castes."
- 5. In G.O.Rt.No.535 M.A., Dated:8.7.98, Government have issued guidelines to be followed for construction of shopping complexes under goodwill auction. Under the said guidelines, point No.13 reads as follows;

"The usual reservations for S.C, S.T. and Physically Handicapped in the matter of letting out the shops will continue. The procedure for auction based on goodwill deposit, however, being the same.

6. In view of the observations made by the Committee on Welfare of SCs, it is hereby requested to strictly follow the above provisions of the A.P.M., Act, 1965 in allotment of shops to SCs & STs and it should also be ensured that shops so allotted should be within prime locations inside the shopping complexes. Any failure in following rule of reservation and this instructions will be taken serious view.

Sub:- SJSRY - DWCUA Component - entrustment of Sanitation of work to Women groups - continuation of Sanitation work - instructions - Certain - Reg.,

Ref:- 1. Govt Memo No. 21778/UBS-2002 M.A., dt. 25.12.2002

2. End. No. 6755/2002-N4, dated 30.01.2003 of the Commissioner & Director of Municipal Administration, A.P., Hyderabad.

The attention of the Commissioners of Municipalities / Municipal Corporations are invited to the references cited wherein certain instructions were issued for taking up of sanction of sanitation work to DWCUA groups under SJSRY scheme subject to certain conditions laid down therein. The following are major conditions for under taking sanitation work through DWCUA groups:

- a) that the contract period should be for a period of 3 years or until liquidation of loan sanctioned, which ever is later.
- b) even after liquidation of the loan these DWCUAs assisted units shall be given a priority in allotment up to 50% of the privatized sanitation/ total sanitation work.
- c) DWCUA groups can be allotted sanitation work in all the ULBs up to 50% of the privatized sanitation/total sanitation work.
- 2. In this connection, certain complaints are being received from DWCUA groups that fresh tenders are being called and this may lead to termination of the existing contract for sanitation with the DWCUA groups. Hence, there would be loss of livelihood and will cause considerable financial problems to the existing DWCUA groups, which have undertaken to take up municipal sanitation.

- 3. Therefore, the Municipal Commissioners of Municipalities/Municipal Corporations are hereby instructed as follows:
 - Irrespective of whether even if the DWCUA groups have completed their contract period for sanitation work, they are given a uniform extension by 6 months.
 - Municipal Commissioners are instructed that the existing DWCUA groups which
 have been entrusted with sanitation work should be continued and new tenders for
 fresh entrustment of sanitation work should not be called.
 - In case such tenders have been called where DWCUA groups are doing sanitation work, the same should be cancelled with immediate effect
