ORDER:

Whereas, by section 101 of Andhra Pradesh Re-organization Act, 2014 (Central Act No.6 of 2014), the appropriate Government i.e. the State of Telangana is empowered by orders, to make such adaptations and modifications of any law (as defined in section 2 (f) Act) made before 02,06 2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in the state of Telangana before expiration of two years from 02.06.2014; and ther upon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other Competent Authority;

- And whereas, in the G.O 2nd read above, orders were issued adapting the Andhra Pradesh Municipalities Act, 1965 to the state of Telangana along with amendment to the proviso under sub section 4 of section 277, substituting the words "thirty years" for the words "twenty five years";
- And whereas, it has become necessary to adapt the Andhra Pradesh Municipalities (Regulation of Receipts and Expenditure) Rules 1968, which were in force as on 01.06.2014, for the purpose of facilitating its application in relation to the State of Telangana;
- Now, therefore, after careful examination, Government have decided to adapt the Andhra Pradesh Municipalities (Regulation of Receipts and Expenditure) Rules 1968, which were in force as on 01.06.2014, alongwith modifications.

5. Accordingly, the following Notification will be published in an Extraordinary issue of the Telangana State Gazette Dt:31.03.2016.

NOTIFICATION

In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organization Act, 2014 (Central Act No.6 of 2014), the Governor of Telangana hereby makes the following order, namely:-

- (1). (i) The Order may be called the Andhra Pradesh Municipalities (Regulation Receipts and Expenditure) Rules 1968 (Telangana Adaptation) Order, 2016.
 - (ii) It shall be deemed to have come into force with immediate effect.
- (2). For the purposition this order, and rules adapted herein, the expression "the State" shall have the meaning and area as specified in Section 3 of the Andhra Pradesh Reorganization Act, 2014.

- (3). In the Andhra Pradesh Municipalities (Regulation of Receipts and Expenditure) Rules 1968:
 - throughout the rules, except occurring in a title or citation or description etc., for the words, "Andhra Pradesh" the word "Telangana" shall be substituted.
 - (ii) (a) In Sub-clause (4) of clause (h) of sub-rule (1) of Rule 12 of Andhra Pradesh Municipalities(Regulation of Receipts & Expenditure) Rules, 1968, for the words "twenty-five years" the words "thirty years" shall be substituted.
 - (b) In Sub-clause (4) of clause (h) of sub-rule (1) of Rule 12 of Andhra Pradesh Municipalities(Regulation of Receipts & Expenditure) Rules, 1968, for items (a),(b) & (c) the following items shall be substituted, namely:-.
 - (a) Rent at 15% of the current market value of the property per annum i.e., both the structures and buildings fixed by Registration Department under the Andhra Pradesh Revision of Market Value Guidelines Rules,1998 (or)
 - (b) Rent at 50 percent above the earlier rent, or:
 - (c) Rate obtained in open market auction with the first right of refusal going to earlier lessee, provided his lease is considered for 5 extra years in exceptional cases.
