With reference to the above, a meeting was held on suggestions for formulation of guidelines for 'Housing for All by 2022' at MoHUPA, New Delhi on 14-08-2014.

In the meeting it was revealed that there is a shortage of 18.78 million houses in India out of which more than 95% shortage is for EWS and LIG houses.

- 1. The Housing shortage in Telangana is reported to be high.
- 2. Urban poor requiring houses are categorized as
 - a. Slum dwellers,
 - b. Urban poor living in non slum areas,
 - c. Prospective migrants and
 - d. Homeless and Destitute.

Hence, different strategies shall be worked out to cater the needs of the above groups.

- 3. The slums are located on different types of lands such as
 - a. Central Govt. land / State Govt. land / ULB land,
 - b. Private land and
 - c. Un authorized colonies.

Also some slum dwellers have pattas or some other security of tenure and some do not have security of tenure.

- Different types of housing strategy shall be implemented for different types of tenure.
 The slums shall be developed in different models such as
 - a. In-situ development,
 - b. Relocation wherein existing slum is on untenable lands
 - c. It is envisaged to take up housing in PPP mode using land as a resource.

In the meeting it was requested to send a proposal taking into consideration all the above mentioned categories.

Hence, you are requested to submit a Project report on Housing for All the above categories along with information in the proforma enclosed.

This should be treated as most urgent.
