**Sub:** Mpl Admn Dept- Hon'ble Chief Ministers instructions in the Collectors conference held on 14.12.2016-Development of burial grounds in the ULBs- Certain instructions issued- **Reg.**

**Ref:** Hon'ble Chief Ministers instructions in the Collectors conference held on 14.12.2016.

I invite attention of all the MCs to the subject cited, wherein time and again it was instructed that burial grounds in the ULBs shall be developed in a most aesthetic manner with all facilities and useful to all the sections of community according to their faith. However, many MCs have not taken any action on this issue and neither the compliance report along with photos was submitted to this office by the ULBs who have complied the instructions. The Hon'ble Chief Minister during the collectors conference held on 14.12.2016 have issued strict instructions to develop burial grounds in the ULBs with all facilities immediately.

2. In view of above, the following further instructions are issued for strict compliance:-

1. Land for burial grounds shall be identified immediately if not done so far, suitable for all sections of community
2. Following facilities shall be invariably provided in the burial grounds
  - i. Green fencing (**From Haritha Haram**)
  - ii. Changing rooms for men and women separately (**4 Nos**)
  - iii. Toilets for men and women separately with running water (**4 Nos**)
  - iv. Lockers for storage of ash and material (**12 Nos**)
  - v. electrical crematorium (**1 No**)
  - vi. Required no. of platforms (**2 No**)
  - vii. Water supply with bore (**1 No**)
  - viii. Clear way for entrance and exit
  - ix. All the Hindu burial grounds shall be named as "Vikuntha Dhamam" (**Board**)
3. Besides the aesthetics the above basic requirements shall be provided in the burial Grounds without fail.

3. The RDMA are requested to review the plight of existing burial grounds in the ULBs and also burial grounds proposed for development on the above lines during the review meeting and submit factual reports to this office on monthly basis without fail.

4. The MCs are once again informed that this item of work shall be given top priority and shall be monitored hence forth during all the review meetings and video conferences. Hence, the MCs shall evince special interest on the above item of work and develop all the burial grounds in the town and report compliance.
