**ORDER:**

4. The Commissioner, Warangal Municipal Corporation is requested to relieve Sri K.Prabhakar, Sanitary Inspector so as enable him to report as Municipal Commissioner on O.D basis at Andol-Jogipet Nagarapanchayathi.
