Therefore while enclosing the Authorization copy of the DTA, the Municipal Commissioners of Twenty (20) Nagarpanchayats are directed to utilise the entire 14th FC grant immediately on priority basis and send the UCs for the utilized amount component wise and voucher wise in the prescribed proforma.
