If the expenditure incurred for the above items of work is more than the amounts sanctioned under 13th Finance Commission Grants, the difference amount shall be met from the Municipal General funds.
- Therefore while enclosing the Authorization copy of the DTA, the Municipal Commissioners of Twenty Two (22) Nagar Panchayats are directed to utilise the entire 13th FC grant immediately on priority basis and send the UCs for the utilized amount by 31-03-
