Sub:- Conduct of **Pulse Polio NID round on 18th January, 2015** – Extending support – Requested - Reg.

Ref:- The Commissioner of Health & Family Welfare, Telangana State, Hyderabad Lr.No.15/JD(CH&I)/2014-15, Dated:30.12.2014.

The attention of all the Municipal Commissioners of Urban Local Bodies in the State and all the Regional Director cum Appellate Commissioners of Municipal Administration in the State are invited to the reference cited, wherein it has been informed that,

- The first round of pulse polio NID will be conducted in the State on 18.01.2015 as booth day activity followed by House-to-House activity on 19th and 20th January by administration of tOPV vaccine to all the children in the age group of 0-5 years as was done in the previous rounds.
- This year main focus will be on vulnerable groups like beggar community, nomadic tribes, fishermen community, migratory families, construction labour, urban slum dwellers residents of peri urban areas, overlapping the surrounding Panchayats, new colonies outside the towns, tourist groups, families with working hours that do not coincide with the team visits, agricultural families living/working in the fields.

Therefore, for effective conduct of the NID round, and also so as to have combined effort, which is instrumental as such there is no single wild polio virus case reported across the country since January 2011, the Municipal Commissioners of all Urban Local Bodies are instructed –

- To own the PPI programme of their cities / towns by verification of micro-plans and ensure total coverage of the areas by including all urban slums, peri-urban areas, apartment complexes, and construction sites and to involve self-help groups in urban areas through PDs of MEPMA.
- Suitable buildings under their jurisdiction to function as PPI posts.
- All the Municipal Field Personnel (Sanitary Inspectors, Supervisors, Bill Collectors etc) to be involved in the Pulse Polio Programme.
- Special efforts for conducting house-to-house visits in apartments to cover missing children.
- Involvement of resource persons from MEPMA, Town Planning Unit in preparing action plans.

It is, therefore, instructed that the Municipal Commissioners of all Urban Local Bodies shall bestow their personal attention in successful conduct of the NID round of the proposed Pulse Polio Programme on 18th January, 2015 and followed by the house to house activity on 19th and 20th January, 2015.

All the Regional Director-cum-Appellate Commissioners of Municipal Administration are also instructed to ensure that the Pulse Polio programme is done successfully by extending full support of the Municipal Commissioners concerned.
