The Municipal Commissioner will be personally held responsible for any deviation of 13th Finance Commission grants to other works. If the expenditure incurred for the above items of work is more than the amounts sanctioned under 13th Finance Commission Grants, the difference amount shall be met from the Municipal General funds.
- 5. Therefore while enclosing the Authorization copy of the DTA, the Municipal Commissioners of Twenty Four (24) Nagarpanchayats are directed to utilise the entire 13th FC grant immediately on priority basis and send the UCs for the utilized amount by

30-05-2015 component wise and voucher wise in the prescribed proforma. Any delay in submission of UCs will be viewed very seriously.
