The attention of the Officials of the Department mentioned in the address entry is invited to the reference cited and they are informed that Property Tax is a major source of revenue to the Municipalities and Municipal Corporations in the State which is being reviewed frequently at the top level i.e. by the Hon'ble Chief Minister, Principal Secretary to Government and Commissioner & Director of Municipal Administration wherein dissatisfaction is expressed time and again over poor collection of Property Tax

2. On perusal of collection of Property Tax in the ULBs in the State, it is found that collection of Property Tax is very poor in the following ULBs:
