In continuation to the Circular instructions issued in the reference 4th cited, the Municipal Commissioners are requested to implement the following points to improve the sanitation and solid waste management in the ULBs;

1. All the Municipal Commissioners of the selected ULBs are requested to extend necessary cooperation and also provide necessary information / data related to the sanitation and solid waste management to the Agency.
2. All the MCs shall keep in mind that the data/information collected by the Agency will reflect the status of ULB with regard to sanitation and solid waste management in all India Sanitation Ranking which will be published by MoUD, Government of India.
3. Clean all the backlog garbage heaps, debris, drain silt, mounds, and bushes etc., on war footing basis
4. Focus on segregation, door to door collection and processing of waste
5. Sweep all the roads, lanes and by-lanes regularly.
6. Special focus community toilets, public toilets and toilets at schools with regard to water supply, lighting, cleanliness and hygiene.
7. Water supply and quality of water supplied
8. Clean and hygienic conditions in slum and scattered areas.

9. Cleaning of Drains. Focus on cleaning of storm water drains

10. Resource recovery of waste through compost and sale of recyclables.
