Sub: PS-Mpl Admn Dept- Telangana ku Haritha Haram-Certain instructions issued to take up block, avenue and Scattered plantation in the review meeting held by Hon'ble Chief Minister-Reg.

6. Instructions issued by the Hon'ble Chief Minister in the review meeting on Telangana ku Haritha Haram held on 11.05.2015.

The attention of the Commissioners of all ULBs is invited to this office reference 5th cited, wherein detailed instructions were issued to take up plantation i.e., Avenue, Block and Scattered plantation in all ULBs.

2. In addition to the above instructions it is to inform that during the review meeting held on Haritha Haram on 11.5.2015, the Hon'ble Chief Minister has been pleased to issue the following instructions:-

- i. Every House Hold shall plant atleast two plants which are fruit bearing especially in weaker section colonies. Distribution through students may be taken up.
- ii. All ULBs in the State shall develop Smruthivanams as follows:
 - a. One Smruthivanam in each ULB i.e., Municipality/Nagarpanchayat
 - b. Two Smruthivanams in each District Head Quarter Municipality
 - c. Three Smruthivanams in each Municipal Corporation and
 - d. Four Smruthivanams at Greater Warangal Municipal Corporation
- iii. For the safety and Survival of plants in internal roads, Road margins/ Central media etc., in Avenue Plantation instead of procuring iron/cement tree guards, placing of "Kampa Chettu" may be taken up to cut down the expenditure, wherever tree guards are not sponsored by philanthropists/NGOs.

3. Therefore, all the Commissioners of ULBs are requested to contact the District Forest Officers concerned immediately and place their indents for the requirement of plants, seedlings etc., procure and transport them to a central place in their ULB for easy distribution of the same to all the households after the onset of monsoon. They are also requested to use the tractors and trailers available with the ULBs for transportation of plants from the nearby nurseries of the Forest Department duly enlisting the co-operation of the Forest Department, which measure will cut down the expenditure.

4. Regarding raising of Smruthi Vanams in the ULBs as per the instructions issued by the Hon'ble Chief Minister, all the Commissioners are requested to contact Lions, Rotary, JAYCES Clubs etc., and other Philanthropical Institutions, students and teachers of Schools & Colleges, Ward Members, Chairperson, Mayors etc., and enlist their whole hearted co-

operation in developing the Smruthi Vanams and ensure that these Vanams are raised. They should take all necessary steps to complete the ground work before the onset of monsoon in the already identified sites for taking up plantation under Smruthivanam. They are also instructed to use "Kampa Chettu" as tree guards in avenue plantation taken up instead of making iron/cement tree guards to cut down the expenditure. The Commissioners are also instructed to co-ordinate with the District Collectors concerned and follow the instructions given from time to time for making success of the plantation.

5. All the Commissioners of the ULBs are also instructed to bring about community awareness duly involving Self Help Group, Social Welfare Groups, Colony Welfare Associations, Merchant Associations for active participation and ensuring the survival of plantation taken up under "**Telangana Ku Haritha Haram**". These associations may be allotted to certain identified locations for overseeing the plantation and post plantation activity. Reporting system may also be generated on the survival of plantation taken up.

6. The above instructions and the time schedule issued shall be followed scrupulously in true spirit failing which severe action will be initiated against the person responsible. These instructions and proformas are available in the website of www.cdma.gov.in under Haritha Haram. All Municipal Commissioners should ensure that the required information and status of pre-plantation and post plantation activities shall be uploaded in the proforma from time to time.
