The attention of the Commissioner of all the Urban Local Bodies (Municipalities & Municipal Corporations) in the Telangana State (except Greater Hyderabad Municipal Corporation) are invited to the reference cited and informed that the Government while enclosing the Alert Note No:26 (C.No.485/D1/V&E/2016) Dt:02.04.2016 have requested to take immediate necessary action on the recommendations of the V&E Alert Note and also to submit the Action Taken Report. The instructions of the V&E Alert Note are:

- a) Strictly implement the provisions of Municipal Laws for taking action to demolish/remove the unauthorized towers who fail to pay prescribed charges/fees.
- b) Strictly implement the guidelines/conditions mentioned in G.O.Ms.No.380 at the time of issuing new permissions for erection of cell towers to prevent the accidents and radiation.
- c) Direct all the field functionaries to conduct periodical inspections thoroughly to prevent installation of unauthorised towers in their jurisdiction.
- d) To collect additional tax from the land owners who have allowed the installation of Cell Towers on their premises.

- e) To register rental agreements between companies and building owners and accord installation permissions after payment of charges/permit fee to curb evasion of revenue to the ULB.
- 2. Therefore, the Commissioners of all the Urban Local Bodies (Municipalities & Municipal Corporations) of the Telangana State (except Greater Hyderabad Municipal Corporation) are instructed to implement the above said Vigilance and Enforcement instructions and to intimate the action taken in the matter to Government, at the earliest.
