Sub: Mpl Admn Dept- Establishment of Vegetable and Non-Vegetarian A/c Markets in all Municipalities in the State-Identification of No. of localities in each Municipality /Town for sale and purchase activities-Proposals called for-Reg.

Copies of the references $1^{\rm st}$ and $2^{\rm nd}$ cited, are enclosed to this circular for ready reference.

- 2. The Municipal Commissioners of all ULBs, RDMAs and District Collectors are informed that in the reference 1st cited, the Addl. Secy to Chief Minister requested the Prl Secys of MA & UD and Agriculture Marketing & Co-opn, to get proposals from the District Collectors to establish Vegetable and Non-Vegetarian A/C markets in hygienic conditions with necessary facilities in all the Municipalities for this purpose No. of localities shall be identified in each Municipality/Town for sale and purchase activities. The Addl., Secy to CM also requested to get the proposals for upgradation of existing Rythu Bazars in the same manner and take action for implementation of Hon'ble Chief Ministers orders at the earliest.
- 3. Further, they are informed that in the reference 2nd cited, Government have requested the C&DMA to identify the No. of localities in each Municipality/Town to establish Vegetable and Non-Vegetarian A/C markets for sale and purchase activities and to get necessary proposals from all the District Collectors to establish the same.
- 4. Since Government directions are specific to get necessary proposals from all the District Collectors to establish the Vegetable and Non-Vegetarian A/C markets in hygienic conditions with all facilities in all the Municipalities and to identify localities in each Municipality/Town, all the Municipal Commissioners of ULBs are directed to identify the suitable sites in consultation with Revenue Department and submit suitable proposals in triplicate to the District Collectors concerned within 15 days in the proforma prescribed (copies enclosed). The Regional Directors of Municipal Administration Hyderabad and Warangal are requested to issue necessary instructions to all Municipal Commissioners in their jurisdiction and ensure that the proposals are submitted by the respective Commissioners to the District Collectors within 15 days from the date of receipt of this letter by personally pursuing with them.
- 5. In addition to the above, in pursuance of the directions of the Government, the following instructions are hereby issued to the Municipal Commissioners of the State:-

- Till upgradation of existing Rythu Bazars/Vegetable/Non-Veg markets into A/C Markets with all amenities, the MCs shall ensure that the Vendors shall sell their products (goods) by putting them on the elevated platforms, i.e., Tables and constructed platforms instead of putting them on ground which will lead to contamination with bacteria/virus etc.
- The Non- Vegetarian vendors shall maintain neat and hygienic conditions, i.e., Nylons nets for covering the food items, maintain proper light and ventilation, keep the waste generated at separate bins handed over to Public Health workers and certification stamps of the Veterinary Doctors etc.,

Ensure ban of plastic carry bags below 40 microns in the markets and encourage paper and cloth bags etc.,

Maintain hygienic conditions i.e., separate team for timely cleaning of waste generated in the market premises.

sufficient place is available, encourage market committees for onsite compost/vermi compost/biomethanation of vegetable waste.

Maintain proper drainage system in the markets to avoid water logging during rainy season.

Ensure proper water supply and toilet facilities in the markets

The street vendors shall be instructed to use proper covering on the food items to be sold in the markets and on the roads

The District Collectors are also requested to scrutinize the proposals submitted by the Municipal Commissioners and furnish a consolidated proposal within a month from the date of receipt of this circular to this office in triplicate i.e., by 10.10.2014, so as to enable this office to furnish a proposal to Government. It is also requested to review the above items in "Urban Day" meetings with all the MCs in your District.
