The Attention of all the RDMAs and Commissioners of all the ULBs in Telangana State is invited to the references cited, wherein Annual Development Plans (ADPs) were submitted by the ULBs for Utilization of 13th FC Grants, for improvement of Urban Services every year starting from F.Y.2010-11 to F.Y.2014-15. Accordingly orders were issued by this office for execution of works sanctioned and also requested to submit revised proposals for the works deferred for the F.Y.2010-11 to F.Y. 2014-15. But most of the ULBs have not submitted revised proposals for the balance amounts.

- Further, I once again bring to your notice that in the admissible components of 13th FC, street lightening is one of the major component i.e., (providing of third wire, capacitors and on-off system for the street lightening) and also a provision for allocating not more than 10% of the releases is also provided for the municipalities. But it is noticed that in most of the Municipalities single phase street lightening is being used and most of the street lights are burning whole day consuming electricity to a larger extent.
- In this connection, I instruct you to give priority for the street lightening component while submitting the revised proposals for the balance amount remained for the 13th FC F.Y's 2010-2011 to 2014-2015 if no works are proposed under street lightening earlier.
- I, therefore, request you to submit revised proposals for the balance amount remained for the F.Ys 2010-2011 to 2014-2015 at an early date for taking further action.
