Govt of Telangana R:

Whereas, by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the State of Telangana is empowered by order, to make such adaptations and modifications of any law made before 02-06-2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in the State of Telangana before expiration of two years from 02-06-2014; and thereupon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other competent authority;

And whereas, it has become necessary to adapt, with modifications/ amendments, the Andhra Town Planning Act, 1920 for the purpose of facilitating its application in relation to the State of Telangana;

Now, therefore, after careful examination Government have decided to adapt the said Andhra Pradesh Town Planning Act, 1920 which is in force as on 1.6.2014.

Accordingly, the following Notification will be published in an Extra dipary issue of the Telangana State Gazette, dated:28.04.2016. hs le p

In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the Governor of Telangana hereby makes the following Order, namely:-

- 1. (1) This order may be called "Andhra Pradesh Town Planning Act, 1920" (Telangana Adaptation Order) 2016.
 - (2) It shall be deemed to have come into force with effect from 2.6.2014.
- The Andhra Pradesh General Clauses Act, 1891 shall apply for the interpretation of this Order as it applies for the interpretation of a State Act.
- For the purpose of this Order, and the Act adapted herein, the expression "the State" shall have the meaning and area as specified in section 3 of the Andhra Pradesh Re-organisation Act, 2014.

- In the "Andhra Pradesh Town Planning Act, 1920":-4.
 - (1) Throughout the Act, for the words "Andhra Pradesh" (occurring otherwise than in a citation or description or title of other enactments), the word "Telangana" shall be substituted;
 - (2) In section 46-A for the words and expression "as on the date of commencement of the Andhra Pradesh Town Planning Act, 1920" the words and expression "as on 28.10.2015" shall be substituted.
