ORDER:

In the G.O. 1st read above, orders were issued for waiver of interest on arrears of property tax and interest on current year dues on property tax i.e., 2013-14 as one time measure provided that the assesses pays total arrears and current year tax in one lump sum or installments before 31-03-2014 and also directed to adjust the interest already paid by the Tax payers on arrears and on current year Property Tax demands during the year 2013-14 towards the future Property tax payments and no cash refund shall be made.

2. In the 2nd & 3rd read above, in the circumstances reported by the Commissioner and Director of Municipal Administration, Telangana, Hyderabad and the Commissioner, Greater Hyderabad Municipal Corporation has requested to extend the period for waiver of the interest on current year property tax dues till **31st August, 2014** for the year 2014-15 in the Municipalities and Corporations including Greater Hyderabad Municipal Corporation.

3. Government after careful examination of the entire matter and in exercise of the powers conferred under Section 387-A of the A.P. Municipalities Act, 1965 and under Section 679-E of Greater Hyderabad Municipal Corporation Act, 1955, hereby extend the period for waiver of the interest on current year dues on property tax for the year 2013-2014 and for the year 2014-15 in the Municipalities and Corporations including Greater Hyderabad Municipal Corporation till **31st August, 2014** and also direct to adjust the interest already paid by the Tax payers on current year dues during the year 2013-14 and also 2014-15 towards the future property tax payments and no cash refund shall be made.

4. The Commissioner and Director of Municipal Administration, Telangana State / the Commissioner, Greater Hyderabad Municipal Corporation, Hyderabad and all the Commissioners of Municipalities/ Municipal Corporations in the State shall follow the above orders scrupulously.
