The attention of all the MCs is invited to the sub and reference cited above.

- 2. In view of above, the following instructions are issued for strict compliance:
  - a. Hoardings/ Flexi Boards(Two-Board A and B) together be erected in every junction or prominent place for information to the public on precautionary measures and other aspects on control of covid 19 in view of emergence of second wave in some states in the country. The design for two boards-A&B is enclosed.
  - b. Minimum 10 hoardings (two boards- A&B in each location) to be erected in each ULB covering all important junctions and other prominent places.
  - c. The hoarding shall be strong to withstand any adverse whether duly following all safety measures. There shall not be any changes to the designs and they shall be printed in appropriate size so as to be clearly visible and readable to the citizens.
- 3. The expenditure on the above to be judicious and can be met from General funds/Pattana Pragathi funds.
- 4. The above work shall be completed by 23.11.2020, 3 PM and compliance should be submitted in the format enclosed by 4 PM.
