

employees who have died due to Covid-19 in all ULBs (except GHMC) – Completion of Compassionate Appointments immediately not more than 7 days from the date incident – Instructions issued - Reg.

The attention of the RDMAs, Warangal/Hyderabad and all the Municipal Commissioners in the State (except GHMC) are invited to the subject and references cited wherein the references 1st & 2nd cited, the Government have issued instructions to lay down the procedure to be followed in providing immediate permanent relief to the family of a Government employee who dies in harness by providing compassionate appointments to the dependents of Government employees.

- 2. Further, the Government in the references 3rd & 4th cited, have issued Telangana Municipal Ministerial Subordinate Service Rules for categories in Municipal Administration Department and delegated the powers to appointing authority to the certain category of posts in ULBs.
- 3. In this regard, the RDMAs, Warangal/Hyderabad and all the Municipal Commissioners in the State (except GHMC) are hereby informed that the Hon'ble Minister, MA&UD Dept have issued instructions for immediate completion of Compassionate appointments to the dependents of Government employees who have demised due to Covid-19 in all the Urban Local Bodies.
- 4. In view of the above, the RDMAs, Warangal/Hyderabad and all the Municipal Commissioners in the State (except GHMC) are instructed to examine the Compassionate appointments of the dependents of deceased Government employees as per the rules in vogue who have demised due to Covid-19 and complete within (02) days from the date of receiving of these instructions and

furnish compliance to this office immediately. The RDMAs shall submit the compliance report of ULBs of their region, and further directed to submit weekly report on this in the Format Enclosed.
